# CAMPER VAN PARKING

## EMPLACEMENT CAMPING-CAR

### IMPORTANT :

- Barbecues are prohibited
- Tents, caravans, trailers, habitable leisure vehicles and any towed vehicles any towed vehicle are not accepted
- Sewage disposal is prohibited on pitches
- Household waste, rubbish of any kind and paper must be disposed of in the rubbish bins.
- Before leaving the campervan site, you must inform the person in charge at least 30 minutes in advance.

**Pitches are reserved for festival-goers with a Festival Clin d'Oeil pass**

# CAMPER VAN PARKING

## RULES OF PROCEDURE MOTORHOME AND VAN PITCH

Having regard to the General Code of Local Authorities. Considering the development of the CAMPING-CAR ET VANS area in the municipality of Reims.

Considering that it is the responsibility of the Clin d'Oeil Festival to take all necessary measures to prevent accidents and to safeguard the good order, safety, health and tranquillity of everyone. Considering that the management of customers, for the collection of stays, management of reservations by the CinéSourds association within the framework of the Clin d'Oeil Festival.

### GENERAL

#### ARTICLE 1 CONDITIONS

Parking on the Festival Clin d'Oeil de Reims location is allowed from Tuesday 30 June to Monday 6 July 2026 for motorhomes and vans. Tents, caravans, trailers, recreational vehicles and any towed vehicles are not accepted. The pitches are only available to festival-goers with a Clin d'Oeil Festival pass

#### ARTICLE 1.1

The CAMPING-CAR and VANS pitch has 40 numbered pitches

#### ARTICLE 2 RATES

3 rates are in force depending on the dimensions of the motorhome and vans:

**1. Motorhome - 6 meter**

Weekend passes (Friday to Monday): €80

Weekly passes (Tuesday to Monday): 110€

**2. Motorhome + 6 meters**

Weekend passes (Friday to Monday): 100€

Weekly passes (Tuesday to Monday): 130€

**3. Vans**

Weekend passes (Friday to Monday): 70€

Weekly passes (Tuesday to Monday): 100€

### RULES OF USE

#### ARTICLE 3

To access the pitch, a personal motorhome PASS is mandatory. Only one PASS per vehicle is accepted. It is mandatory to provide us with your surname, first name, registration number and mobile phone number (to be contacted in the event of an alert). Reservation is required. Customers must affix the ticket to the windshield at the entrance and exit and present it to the security guards.

#### ARTICLE 4

Pets are allowed, but must be tied. Their droppings must be picked up by their owners. The owners will ensure the tranquillity of everyone.

#### ARTICLE 5 SAFETY INSTRUCTIONS

Barbecues are prohibited. In the event of a fire, notify the emergency services immediately (114 or 18). Gatherings are forbidden between 10 p.m. and 8 a.m. Unpacking and tents are not allowed on the pitch. Customers must respect each other and observe perfect correctness with regard to the neighborhood (noise and health).

### RESPONSIBILITY

#### ARTICLE 6 CLEANLINESS

Each customer is responsible for the state of cleanliness of the location where they park. Household waste, waste of any kind and paper must be deposited in the bins. Waste water evacuation is prohibited on the pitches. Checks will be carried out.

#### ARTICLE 7

Customers are required to respect the rules of good conduct: parking on a single pitch and use of only one electrical outlet per pitch.

#### ARTICLE 8

Traffic and parking within the site are at the risk and peril of the vehicle drivers who retain custody and control of the vehicle as on a public road. Parking and the resulting traffic constitute a simple authorization and can in no way constitute a contract for deposit, guarding or surveillance. The municipality or the Festival Clin d'Oeil company cannot be held liable. Any customer parked in the area is responsible for any damage they cause or that are caused by people for whom they are responsible, as well as by animals or things in their care. He will therefore be required to make full compensation for the corresponding damages. As a result, each customer must individually ensure that the facilities are respected and remains responsible for the damage they cause.

#### ARTICLE 9

Before leaving the motorhome area, it is imperative to inform a manager at least 30 minutes in advance. This notification makes it possible to monitor the state of cleanliness of the site, in particular the sanitation and disposal of wastewater. Failure to comply with the procedures will be punished by a fixed fine of €50.

#### ARTICLE 10

The CinéSourds association may temporarily close the area for maintenance or upkeep as well as for reasons of force majeure, safety or general interest.

#### ARTICLE 11

Checks may be carried out by a representative of the CinéSourds association, the municipality or the gendarmerie. The latter will also be able to draw up reports in the event of fraud. Any violations (theft of electricity, intrusion without a ticket, etc.) of these internal rules will be noted and prosecuted in accordance with the laws and regulations in force. Theft is punishable by 3 years in prison and a fine of €45,000 (Article 311-3 of the Penal Code).

# CAMPER VAN PARKING

## GENERAL TERMS AND CONDITIONS OF SERVICE FOR THE CAMPERVAN PITCH

### 1. PURPOSE

These General Terms and Conditions of Service govern the management of Campervan pitches in our parking area. They define the rights and obligations of the parties in the context of the reservation and use of the pitches.

### 2. BOOKING AND PAYMENT

#### 2.1 Booking :

A Campervan pitch can be booked online, subject to availability.

#### 2.2 Payment :

Payment is due at the time of booking. Accepted payment methods include credit cards.

#### 2.3 Confirmation :

A booking confirmation will be sent by email after receipt of payment.

### 3. RATES

#### 3.1 Prices :

The prices of the pitches are displayed on our website.

### 4. ARRIVAL AND DEPARTURE

#### 4.1 Arrival :

Arrival is possible from 10:00 a.m.

#### 4.2 Notification :

Before leaving the Campervan area, it is imperative to inform a manager by text message (+3368995439) at least 30 minutes in advance. This notification makes it possible to monitor the state of cleanliness of the site, in particular the sanitation and disposal of wastewater. Failure to comply with this procedure will be punished by a fixed fine of €50.

### 5. USE OF THE LOCATION

#### 5.1 Cleanliness and Sanitation :

Users are responsible for keeping their site clean and following waste management guidelines.

#### 5.2 Wastewater :

No evacuation planned in the car park, for the evacuation of wastewater, you must go to 1 Allée Polonceau, 51100 Reims.

#### 5.3 Pets :

Pets are allowed provided that they are kept on a leash and that their owners respect the rules of cleanliness.

### 6. RULES OF CONDUCT

#### 6.1 Respect :

Users must respect the peace and quiet of other campers and avoid any disruptive behaviour.

#### 6.2 Safety :

Safety instructions must be followed at all times. The use of open fires is strictly prohibited.

### 7. CANCELLATION AND REFUND

#### 7.1 Cancellation by the Customer :

In the event of cancellation by the Customer, the following conditions apply:

In case of cancellation by the customer, we will not refund you. We advise you to subscribe to the cancellation insurance available on our ticketing website. This insurance, managed by a third party, allows you to benefit from a refund of 70% of the amount of your reservation in the event of cancellation for reasons covered by the insurance. The terms and conditions of this insurance are detailed on the ticketing website.

#### 7.2 Cancellation by the Organizer :

In the event of cancellation by the Organizer for reasons beyond the control of the customer, the customer will be refunded in full.

### 8. LIABILITY

#### 8.1 Damage :

The organiser cannot be held liable for damage to property or people at the Campervan site, except in the case of gross negligence or wilful misconduct.

#### 8.2 Insurance :

Users are responsible for their own insurance to cover the risks associated with the use of the Campervan area.

#### 8.3 Rules of Procedure

Customers agree to respect the Campsite's internal rules, available on our website. Any serious breach of the internal rules may result in immediate expulsion without refund.

### 9. DISPUTES

In the event of a dispute, an amicable solution will be sought as a priority. Otherwise, the competent courts will be those within the jurisdiction of the organizer's registered office.

### 10. ACCEPTANCE OF THE T&CS

The reservation of a Campervan pitch implies full and unreserved acceptance of these General Terms and Conditions of Service.
